## Stagecoach Crossings Homeowners Assn. Meeting Minutes January 14, 2016

Meeting was called to order at 7 pm.

**Treasurer's Report**. As of Dec 1, Checking account had \$11,203.69. John Z. was paid \$410 for mowing. Old check 1193, \$67.95—Keith asked if anyone knew what this for as there was nothing written in ledger about this. He will continue to research this for next meeting. Savings had \$6,434.70 with \$1.24 dividend. Together, \$17, 638.39. Savings and checking balance as of Dec. 1. MSP, Dennis, John.

**Agenda item**: Dick said we need to think about our dues. If no projects chosen, we could drop dues to \$100. If dues need to be evaluated, he suggested we discuss at this meeting. If lower, determine if we would be able to raise later.

## **Old Business:**

<u>Bug Tree Survey</u>. The subdivision was checked. 14 trees were found, all were taken care of by Gary and John. \$10/tree = \$140.00. John was paid for 5 trees \$50 and Gary for 9 trees \$90. Additionally, 6 standing dead trees were found on the common area which Gary cut and also set slash piles. Gary was paid an additional \$60 (6 trees, \$10/tree). Motion to pay Gary and John, MSP, Keith, Janet.

<u>Slash Piles</u>. Keith reported Keith and Dick burned slash piles. John recommended no burning trees in rocks. Park will be reviewed later. Dick he and Liz woud review.

<u>Property taxes</u>. Dennis and John said taxes on park were increased. Dennis said he talked to the county. Check was received for abatement. Taxes now would be \$81. Was \$695.12 total, refunded the difference. John said this is the way it should be. This should be permanent. Linda asked if taxes would go up if permanent structure put on it.

<u>Right of Redemption</u>. Keith reported finance company paid taxes for this but Chuck Howe paid three days later; Bank let him pay back taxes and interest so everything is back in his name.

Website. Website approved Wikispaces \$50. Linda will invoice Keith. MSP John Keith.

## **New Business:**

Road District. John said culvert should make a world of difference. Discussion was held about binder in section of road.

Brunner Construction. Vanessa updated and said construction would begin January 15.

Snow Removal: Road district plows if 4" or more.

<u>Dues Assessment</u>. Discussion was held about current assessment, \$150 and lowering. The group decided, motion made and vote that if the dues assessment were lowered to \$125 per lot this year due to the HOA having adequate revenue, the assessment may be increased at some point in the future should it be necessary. MSP, Janet, Keith.

<u>Procedure for sending out dues</u>: Janet would change the letter and indicate lot numbers, indicate date due, provide return envelope. Mailing needed to be out by Feb. 1.

Election of officers: Elections will be held in April. Eligibility to hold office was discussed.

Brunner Mailbox: John will take care of this. MSP, Dennis, Keith.

<u>Taxes</u>. Discussion about Keith doing.

Sign for arch. Dennis pointed out that the sign at subdivision entrance needed restaining.

<u>Pond</u>. Group felt it was doing well.
